## ED's adventure in Maharashtra including Gujarat

Mumbai : The Directorate of Enforcement (ED) has raided 26 locations of ABG Shipyard and its directors in Maharashtra and Gujarat in connection with a money laundering case involving ABG Shipyard Bank fraud. It is believed to be the largest banking scam in the country worth over Rs 22,000 crore. The company had borrowed from 28 banks. The CBI had registered a case in this regard.

ABG Shipyard and its directors Rishi Agarwal, Santhanam Muthuswamy and Ashwini Agarwal have defrauded banks to the tune of over Rs 22,000 crore, according to the Central Bureau of Investigation. ABG Shipyard and its flagship

company are engaged in the business of building and repairing ships, with the company's shipyards at Dahej and Surat in Gujarat. According to SBI's complaint, the company had borrowed Rs 2,925 crore from the bank. The arrears are said to be Rs 7089 crore from ICICI, Rs 3634 crore from IDBI, Rs 1614 crore from Bank of Baroda, Rs 1244 crore from PNB and Rs 1228 crore from IOB Bank. ABG Shipyard Limited is the flagship company of ABG Group. The company manufactures and repairs ships at Dahej and Surat in Gujarat. ABG Shipyard Limited was established in 1985 and has built more than 165 ships so far. However, India's one-time largest



private shipyard company is now in debt.

According to the SBI, the company has borrowed Rs 2,925 crore from the bank, Rs 7,089 crore from ICICI Bank, Rs 3,634 crore from IDBI Bank, Rs 1,614 crore from

Bank of Baroda, Rs 1,244 crore from Punjab National Bank and Rs 1,228 crore from Indian Overseas Bank. However, the complaint alleged that it was used in other places without cost for the purpose for which it was shown. The company was sanctioned credit facilities by 28 banks and financial institutions with SBI exposure of Rs 2,468.51 crore. Is. These include diversion of capital, irregularities, breach of criminal trust and use of money taken from banks for other purposes than for the original purpose. The audit revealed that between 2012 and 2017, the accused were accused of misappropriation of funds and illegal activities.

## Prayagraj mass murder : Cops zeroing in on gangs for clues

Prayagraj : A police team has been dispatched to Bihar's Rohtas district in search of missing Kharwar gang members suspected of involvement in the recent murder of five members of a family in Prayagraj's Khevarajpur village.

In November 2021, the police detained six members of this group, alleging that they were engaged in many killings in Prayagraj's rural areas.

The gang members were apprehended during two separate operations in the trans-Yamuna and trans-Ganga zones. Baliram Kharwar and Pradeep Kharwar were shot during an encounter with police, and four of their accomplices "Anish Kharwar, Sumit Kharwar, Sandol Kharwar, and Amraj Kharwar" were also apprehended. However, other gang members "Lavla

Kharwar, Murgi Pankh, and Rohit Kharwar" are still absconding.

Cops and Special Task Force (STF) sleuths investigating the brutal killing of five members of a family have found no motive for the sensational murders, such as enmity, property, or domestic dispute, and are now suspecting the handiwork of west UP-based Ghumantu or criminal gangs. Cops claimed to have gotten some specific clues and identified certain gangs that work on the same pattern of executing killings after deploying the intelligence network and collating past occurrences where the murdering modus operandi was identical.

"Our teams visited places of similar accidents to discover a trend and collect facts that might be beneficial," said SSP

Prayagraj) Ajay Kumar: "We now have some actual leads to follow up on. The teams are on the correct track, and the perpetrators will be apprehended shortly," he continued. "Cops have begun inspecting at more than 20 locations, including derelict colonies on the outskirts of the city and neighbourhoods populated by immigrant labourers. Over 300 mobile phones are also being investigated. Cops have also compiled a list of ghumantu gang members who were detained in Madhya Pradesh and neighbouring states after being found implicated in two murder-cum-dacoity cases in the district. Ghumantu gangs operate in both rural and urban areas, and they are both vicious and thorough in their execution of crime. They acquire as much information as they

can on the neighbourhood, residences, and people before attacking them," he remarked.

"We have started inspecting vehicles on highways at night since these gangs prefer to strike around midnight during summers when more people sleep outside," stated an STF official. "They use iron rods and tree branches to strike their victims. They seek refuge along railway track and highways because it is easier for them to flee after committing a crime. To obtain information on targets, gang members masquerade themselves as merchants, labourers, and even set up temporary businesses in colonies. Senior officers have undertaken multiple brainstorming meetings and developed new security strategies to combat

criminal groups," he added.

Unidentified assailants recently killed a milk dealer and his four family members in Prayagraj's Khevarajpur village. The daughter and daughter-in-law were found naked, raising the possibility that they had been sexually abused.

According to the police, the vaginal swabs were forwarded to the FSL, and any sexual assault on them could only be substantiated once the reports were received. However, the post mortem report indicated that the daughter in-law was pregnant. The five year-old girl, who was found alive at the scene of the crime, was still in shock, and authorities were looking for any important information from the kid that would lead to the identification and arrest of the perpetrators.
